Applications are invited from the faculty members in Government and Aided Polytechnic Colleges under this Department for deputation to M.Tech / ME for the year 2023-24 under Quality Improvement Programme [AICTE QIP (Poly)]. The faculty members, who were permitted to apply by the undersigned and as such who got selection memo / call letter from the respective centre, are directed to submit the application through the online facility provided in the website "www.admissions.dtekerala.gov.in/tpms" with the recommendation of the Principal concerned. Those who have not received selection memo / call letter from the QIP Centre and expecting the same, can also apply on condition that their selection memo / call letter will be produced before the date of Screening Committee meeting.

The Principals concerned are requested to verify the applications submitted by the faculty members and forward the eligible applications with specific recommendation by observing the guidelines of the deputation under QIP.

In the case of faculty members in Aided Polytechnic Colleges, the applications are to be routed through the respective Regional Directorates. The Principals of Aided Polytechnic Colleges should verify the details of number of sanctioned posts, number of persons working against sanctioned post, nature of appointment (permanent / against QIP or leave vacancy) etc of each branch with applications for deputation. The Joint Directors concerned should also verify the list and furnish remarks if any while forwarding the applications received from the Aided Colleges.

Selection for deputation will be finalized in the Screening Committee meeting. The applications not routed through the proper channel or received after the stipulated time will not be considered on any account.
