#### **ORDER**

Vide reference cited an amount of Rs.1 crore (Rupees one crore) was provided for the Annual Plan for the year 2017-18 for implementing for the Assistance of Ph.D and M.Tech Non GATE students of the Engineering Colleges. The amount of the Assistanship will be Rs.20,000/- for Ph.D students and Rs.6,000/- for M.Tech Students per month respectively.

In this circumstances, a draft guidelines for the Assistance-ship for M.Tech Non GATE students is appended below:

# Assistance-ship for M.Tech Non-GATE Students

Teaching and Research Assistance-ship will be provided to the Non-GATE M.Tech students under the scheme of Research Scholarship in all Government Engineering Colleges. The Assistance-ship shall be starting from the month of joining the institution by the students. The amount of the Assistance-ship will be Rs.6,000/- per month. This scholarship is for the financial year 2017-18 only.

### **ELIGIBILITY CRITERIA**

All the regular students, enrolled under various M.Tech programmes in all government Engineering Colleges can apply for assistantship. As per the prevailing institute norms and regulations, the students can apply for assistantship subject to the fulfillment of following conditions.

- 1. A maximum of 5 students in each Govt. Engineering colleges will be benefited by this Scholarship.
- 2. The students must be Indian National only.
- 3. The students must be enrolled under Regular (Full Time) M.Tech programme only. But she/he must be non-sponsored candidate. In the event of his/her conversion from full time to part –time, the assistantship shall be ceased to continue forthwith without any intimation.
- 4. Students who are receiving assistantship from the institute or from any funding agencies, will not be considered for this assistantship.
- 5. The students who are receiving assistantship will be required to devote 8-10 hours per week as teaching/research assistant in their respective departments. This could include tutorials, laboratory classes, development activites undertaken by laboratories, assistance in research and development activites undertaken by faculty members, maintenance and operation of computers, development of software and other central facilities. The HOD will certify the engagement of each of the student for the release of the assistantship every month.
- 6. Scholarship will be disbursed subject to the production of satisfactory attendance and progress report duly certified by HOD on every month.
- 7. The student must abide by CONDUCT RULES of the institute for the M.Tech

Programme. If any disciplinary action is taken by the institute authority against a student, his/her assistantship shall be discontinued from the date of effect of such order. The institute authority shall be requested to intimate such order (for M.Tech students) to the Directorate of Technical Education.

8. The selection of candidates for scholarship is purely on the basis of merit detailed in Annexure A attached with the proceedings.

- 2. Release of scholarships in the  $2^{nd}$ ,  $3^{rd}$  and  $4^{th}$  terms shall be done only after University announces the result to select the students (as per the table above). Arrears, if any, shall be released as and when the select list is made based on the recent University result.
