Applications are invited for NOC from the full time regular / permanent faculty members of AICTE approved Polytechnic Colleges (Government & Aided) under this Department who wish to apply for admission to M.Tech Programme under the scheme "Quality Improvement Programme under AICTE [AICTE QIP (Poly)]" for the year 2025-26.

Only permanent faculty members (such as Lectures/ Head of department/head of sections) who have sufficient teaching experience of two years as on 31.03.2025 can apply for the scheme. The maximum age limit of faculty member applying for deputation under the scheme is fixed as 45 years (as on 01.07.2025) and the candidate should have sufficient remaining service period in Government / Aided Polytechnic Colleges to cover the prescribed bonded period after the completion of M.Tech Programme.

The applicants are directed to submit their application through the online facility provided in the website "www.admissions.dtekerala.gov.in/tpms" and forward the hard copy with supporting documents through proper channel so as to receive in this Office on or before 13.03.2025.

The Principal concerned are requested to receive the applications and forward the same after observing the guidelines issued vide Government Order cited through the respective Regional Directorate of Technical Education within the stipulated time.

The Joint Directors of the respective Regional Directorate should verify the details of faculty members (aided) received from the Principals and furnish the same to this Office within the stipulated time with detailed report regard each candidate.

NOC will be issued by this Office to the eligible candidates through the

head of institutions after scrutinizing the details. The faculty who get NOC from this Office alone are eligible for applying the programme. The Principals concerned should forward the application of eligible faculty of their institutions for admission to M.Tech programme 2025-26 directly to the admission Centre after getting NOC from this Office. The names of QIP centers to which the candidates can apply as per reference (2) .NOC will be issued to only to those candidates who apply the QIP centers as per reference (2).

Time line for submitting applications

- i) candidates can apply through online from 05.03.2025 to 10.03.2025.
- ii) Principals can verify and submit the application through online upto 11.03.2025.
- iii) The Joint Director concerned can verify and submit the applications through online upto 12.03.2025.
- iv) Hard copy of the applications downloaded from the website should be submitted to **planningdte@gmail.com** along with the supporting documents on or before 13.03.2025.

Belated applications will not be entertained on any account.
