ORDER

As per the G.O read above, the power of granting sanction of Condonation of attendance to the students of Diploma course having shortage of attendance less than 65% is entrusted to the Member Secretary SBTE on recommendation of the committee consisting of Senior Joint Director as Chairman, Deputy Director (General) and Joint Controller of Technical Examination as members. The committee shall consider the applications duly recommended by the Principals of those students who have passed more than 50% of subjects of previous semester and completed all academic requirements for the ongoing semester.

The Committee examined the applications for condonation recommended by the Principals of various Polytechnic colleges and found that the details received from the Principals and the reason for shortage of attendance are genuine and admissible. The committee has recommended that the following students are eligible for special condonation.
