The candidates are directed to report for duty before the Head of Institutions concerned with documents in original to prove qualifications, date of birth, community, Non-creamy Layer certificate (wherever necessary) etc., and a health certificate as contemplated under Rule 13 of Part I KSR before **15/07/2026**, failing which their appointments are liable to be cancelled without further notice.

In the event of discharge from service for want of vacancies, candidates may re-register their names in the Office of the Public Service Commission from where they were advised and get themselves re-appointed on further advice, or they may wait for their turn for re-appointment in the department if they desire to continue as a probationer.

No correction of date of birth will be entertained if it is received beyond 5 years from the date of entry in service.

The Head of Institution will admit the candidates only after verifying the particulars regarding qualifications, date of birth, community etc., given in the Public Service Commission's letter (copy enclosed) with documents in original and report the date of joining duty without fail.

The Head of Institution will obtain the necessary details of the candidates duly filled up in the prescribed proforma as required in the G.O. read as 3rd paper above before admitting them to duty, and forward it to this office to facilitate verification.

The Head of Institution will also obtain the necessary details duly filled up in the prescribed proforma as required in the G.O. read as 10th paper above before admission to duty, and forward it for verification by the Kerala Public Service Commission.

The photograph and signature of the candidates must be verified and recorded by the Head of Institution in the identification certificate after joining. The certified identification certificate along with SPARK FORM NO. 1 must be sent to this office for countersignature.

Candidates are directed to submit their thumb impression along with the photograph on the Medical Fitness Certificate issued by a Medical Officer (not below the rank of an Assistant Surgeon).

Candidates who join Government service on or after 01/04/2013 are eligible for the National Pension Scheme (NPS) introduced vide the G.O. read as 8th paper above.

The appointment of the above candidates in their current institution shall be subject to the conditions of the 2026 General Transfer
